4. No Lasix Veterinarian on the grounds. Lasix is the trainer's responsibility.
5. Current negative Coggins test is required.
6. OSRC and USTA Rules to govern with exceptions. Rules of OFRC to govern Stake Races.
7. Track scores five (5) wide. Stakes races will split at eight (8).
8. The Signature Serie will be raced under the published conditions.
9. Entry Fees:
  - \$100 per horse for OFRC Stake Races
  - \$50 per horse for Signature Series Events
  - \$50 per horse for overnight events
10. Purse Distribution: 50% - 25% - 12% - 8% - 5%
11. EIN or SSN for owners are required before any purse money will be paid.
12. The Wood County Agricultural Society is not responsible for accidents on or off the track.
13. The Wood County Fair reserves the right to postpone, declare off, change the program or

refuse any entry. Dangerous or unmanageable horses ineligible to start.

14. OHHA membership card honored at gate on racing days only.
